In Alberta, most landlords require a tenant to pay a security deposit or damage deposit before moving in. A security deposit is a one-time only payment and cannot be more than one month's rent. A landlord must place a security deposit in a trust account within two days of receiving it.

A security deposit is a sum of money that you collect from a tenant in addition to their first month's rent. It is a one-time fee that is refundable.

Every lease agreement should include a security deposit clause. While each landlord has the ability to personalize this clause, the state in which your rental property is located may have certain security deposit laws that you must follow.

No. A landlord cannot keep any of the security deposit to cover damage to the unit if inspection reports were not completed. A move-in inspection must be completed by the landlord and tenant one week before or after the tenant takes possession of the rental unit.

A spokesperson for Quebec Public Security Minister Martin Coiréux, who is responsible for Quebec's rental board, the Régie du logement, said legislative changes may be possible.

#### [Security Deposit and Rent Deposit Clause in Rent Agreement](#)

For e.g., if 3 months rental deposit is made as per the agreement and 2 months is the notice period, when the notice is served, the rent for the 2 months notice period is adjusted against the rental deposit and the remaining 1 month rental deposit is refunded back after making

deductions, if any.

**Unpaid Deposits.** If a tenant doesn't pay the security deposit within 30 days of entering into the tenancy agreement or the pet damage deposit within 30 days of it being required, the landlord may serve the tenant with a notice to end the tenancy.
