Official donation receipts must include the name and website address of the Canada Revenue Agency. The website address has changed to canada.ca/charities-giving. Charities and qualified donees have until March 31, 2019 to update their receipts.

Charities must keep copies of all tax receipts for two years after the year for which the receipt was issued. For ten-year gifts and other gifts of enduring property, copies of tax receipts must be kept for as long as the charity is registered, plus two additional years.

A charitable donation tax receipt can be issued for art over \$1,000 if there is a letter of appraisal from an independent retailer verifying the value. For art under \$1,000 a receipt of purchase must be provided to clearly indicate the fair market value. For art purchased within the past three years, the receipt will be the lesser of the FMV or the Purchase price. For individuals who make art

Grandview Children's Foundation, like all other registered charities, must adhere to the Canada Revenue Agency (CRA) Income Tax Act when issuing charitable tax receipts.

To create a donation receipt, include the name of your charity, and acknowledge that you have 501c3 status under the federal government. You also need to add the donor's name for the receipt to be valid, as well as the date of the donation and the amount of money given. If the donation wasn't financial, include a description like "5 men's shirts."

Receipts must state that they are for official income tax purposes and must contain your full name and address. Finally, each receipt should have the name and website of the CRA, and a unique serial number.
